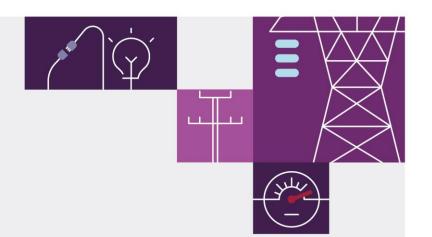

2 Change to Dispatch Schedule Scenarios [WEMDE-20]

AEMO have modified the Scenarios being simulated for the Dispatch Schedule to:

- Simplify the information available to Market Participants
- Allow Market Participants to compare Dispatch Schedules with and without "Available" quantities considered and therefore make informed commitment decisions
- Limit the volume of data persisted to AEMO's database to improve performance
